

PRIVACY POLICY

The information is provided - pursuant to art. 13 of the European Regulation 2016/679 (hereinafter the "GDPR") - exclusively for this website and not for other websites that may be consulted by the user through links.

Data controller and Data Protection Officer (DPO)

The Data Controller is R.T.I. - Reti Televisive Italiane S.p.A., with registered office in Largo del Nazareno, 8 Roma (hereinafter, "Data Controller"). The Data Controller has designated the Data Protection Officer ("DPO") based in Viale Europa 48 - 20093 Cologno Monzese (MI). Types of data processed

Navigation data

The computer systems and applications dedicated to the operation of this website acquire, during their normal operation, some personal data whose transmission is implicit in the use of Internet communication protocols. This information is not collected to be associated with identified data subject, but by their very nature could, through processing and association with data held by third parties, allow users to be identified. This category of data includes IP addresses or the domain names of the computers used by users who connect to the site, the URI (Uniform Resource Identifier) addresses of the resources requested, the time of the request, the method used to submit the request to the server, the size of the file obtained in response, the numerical code indicating the status of the response given by the server (successful, error, etc.) and other parameters relating to the user's operating system and computer environment. These data are processed, for the time necessary, for the sole purpose of obtaining anonymous statistical information on the use of the site and to check its correct operation.

Data provided voluntarily by the user

The optional, explicit and voluntary sending of electronic mail to the addresses indicated on this site involves the subsequent acquisition of the sender's address, which is necessary to respond to requests, as well as any other personal data included in the request. Specific summarised information will be progressively reported or displayed on the pages of the site set up for particular services on request.

Cookie

Italian legislation requires website operators to inform users about cookies and other tracking tools that may be used to record certain data each time users access the site.

Cookies are strings of text that websites (so-called "publishers" or "first parties") visited by the user or different websites or web servers (so-called "third parties") place and store on a terminal device available to the user. The terminals referred to are, for example, a computer, a tablet, a smartphone or any other device capable of storing information, including so-called IoT (Internet of Things) devices.

This website uses only technical cookies, in respect of which - in accordance with current legislation - no consent is required from the person concerned.

Technical cookies are used to carry out navigation or to provide a service to the user. Without the use of these cookies, some operations could not be carried out or would be more complex and/or less secure. They may be permanent or temporary and be used to store information that will be reused the next time you visit the site; without these cookies, the website may not function properly.

Types of cookies

Technical cookies

This type of cookie allows certain sections of the Site to function correctly. There are two categories:

- persistent: once the browser is closed, they are not destroyed but remain until a present expiry date
- session: they are destroyed each time the browser is closed.

These cookies, which are always sent from our domain, are necessary to display the site correctly and in relation to the technical services offered, and will therefore always be used and sent, unless the user changes the settings in their browser (thus affecting the display of the site's pages).

Analytical cookies

The cookies in this category are used to collect information about the use of the site. The site will use this information for statistical analysis in order to improve the use of the Site and to make the content more interesting and relevant to the user's wishes. This type of cookie collects data on the activity of the user and how they arrived at the Site. Analytical cookies may be sent by the Site itself or by third-party domains.

Purpose and legal basis of processing

Personal data will be processed, as part of the Controller's normal activity, for the following purposes:

- to respond to requests or providing the service requested by the user;
- technical management of the Site: e.g. security and control of the proper functioning of the Site;

- processing of aggregate statistical data on the use of the Site.

The legal basis for the processing of such data is the need to respond to the requests of the interested parties and to pursue the legitimate interest of the Data Controller within the limits provided for by the legislation.

Apart from these cases, users' browsing data are kept for the time strictly necessary to manage processing activities within the limits provided for by law.

Optional provision of data

Apart from that specified for navigation data, the user is free to provide the personal data indicated in the request forms to access the services offered by the Data Controller. Failure to provide them may make it impossible to obtain what has been requested.

Data processors and recipients

The processing operations connected to the web services of this site take place at the aforementioned registered office of the Data Controller and are carried out only by personnel employers authorised to process data.

If necessary, the data may be processed by other companies that the Data Controller uses for the maintenance of the technological part of the site (designated as Data Processors pursuant to Article 28 GDPR).

The data may be communicated, for the same purposes as above, to competent public authorities in fulfilment of specific legal obligations.

Personal data are not subject to disclosure.

Retention period

Your personal data will be kept for the period necessary to achieve the above purposes and will be deleted afterwards. Data tracked by analytical cookies are kept for 27 months from collection.

Rights of the data subjects

Pursuant to current legislation on personal data, you may exercise, at any time, the rights under Chapter III GDPR (art. 15-22) including obtaining confirmation of the existence or otherwise of your personal data, knowing its content and origin, verifying its accuracy, requesting its integration, updating or rectification, obtaining its cancellation, portability, opposing its processing for legitimate reasons even limited to a single mode used for processing, revoking the consent given or requesting the limitation of processing.
